**SUMMARY:** Costs for project approved by the Commission and completed since the last bond issue have been accumulated for review. The Commission is asked to approve the final costs of the various projects. Once approved, these costs will be subject to a public hearing on April 27.

10. Consider an Ordinance authorizing the acquisition through eminent domain of additional highway right-of-way needed for roadway improvements in relation to the Kansas Logistics Park project.

**SUMMARY:** Additional street right-of-way and easements are needed for the Kansas Logistics Park improvements. Efforts are underway to acquire those through voluntary conveyances. However, the project timelines being what they are, we need to be in a position to promptly proceed with eminent domain proceedings should that prove necessary. This Ordinance will provide that authorization.

SUMMARY: Each year KDOT goes to all cities requesting projects for Surface Transportation Promotion and Special Bridge Replacement and Rehabilitation Program projects. The Commission will need to review the proposed projects, hold a public hearing to allow public comment and then approve the list of projects to be submitted to KDOT. A memo is enclosed outlining further details of the program.
